I. Call to Order

The meeting was called to order at 2:33 pm.

II. Welcome/Introductions

CQM Support Staff welcomed all attendees, made a statement of the meeting's goal, and made individual introductions. Because it is a new fiscal year, they also updated the contact list with the Medical Provider Network.

III. Integrated Primary Care and Behavioral Health (IPCBH) Service Delivery Model Discussion

A representative from the Part A Recipient office led a discussion on the IPCBH Service Delivery Model and asked the Medical Provider Network for any feedback as they move

along through the document. All the changes presented were based on feedback from the Recipient office, Ryan White Part A providers, and the CQM consultants. Some of the changes included: aligning medical practices with best practices as outlined by the National HIV Curriculum and Health and Human Services (HHS), assuring that care is adaptive to an aging population, and including requirements around women's health and pregnancy planning. The CQM consultant recommended making some final revisions to the document before it is sent out to the Ryan White Part A prescribing providers. They also asked the Network group to help distribute this IPCBH Service Delivery Model to other prescribing providers within their agency.

IV. Health Insurance Continuation Program (HICP) Service Delivery Model Discussion

A representative from the Part A Recipient office led a discussion on the HICP Service Delivery Model and asked if they had any questions about clients utilizing HICP services. A representative from Broward HealthPoint shared an issue with a client who has a high deductible and wondered if HICP could help the client with the high cost of his medications. The Recipient office recommended utilizing Broward Regional Health Planning Council insurance services to help pick specific plans that are eligible with HICP. A representative from Care Resource shared her experience trying to help clients enroll in an affordable health plan and her concerns with premiums being paid on time.

V. Broward RWPA Medical Provider Network Survey

The CQM consultants introduced the purpose of getting feedback from the prescribing providers to help improve the care of clients. They stressed the importance of getting this survey distributed to the Ryan White Part A prescribing providers.

VI. Announcement

The Priority Setting and Resource Allocation (PSRA) committee will be conducting a listening session to discuss concerns from the clients and their recommendations to help improve Ryan White Part A services. It will be held on **Wednesday, April 24th**, in the AHF community room from 3-5 pm. There will be door prizes and refreshments.

The meeting was adjourned at 3:45 pm.
