I. Call to Order

The meeting was called to order at 2:35 pm.

II. Welcome/Introductions

CQM Support Staff welcomed all attendees, made a statement of the meeting's goal, and made individual introductions. Because it is a new fiscal year, they also updated the contact list with the Medical Provider Network.

III. Data Presentation: FY22-23 PSRA Scorecard

The CQM Support Staff reported on the fiscal year 2022-2023 annual data in the form of Priority Setting and Resource Allocation (PSRA) scorecards for the Medical Provider

Network. The purpose of the PSRA scorecards is to inform the PSRA committee of the utilization of these services and the allocation and expenditures for each service category. These scorecards contain data around service utilization, demographics, an overview of the Care Continuum data, and a breakdown of the virally suppressed clients.

The CQM Support Staff identified trends during the fiscal year 2022-2023. Some common trends seen across all the service categories were that the male (75.6%) subcategory comprised most of the population and the Black Non-Hispanic group (52.8%). For the Federal Poverty Level (FPL), the majority of the clients resided in the 300% and lower category making up over 80% of the clients that utilize outpatient ambulatory services.

CQM Support Staff discussed data issues surrounding retention in care and provided the Network a breakdown analysis of those virally suppressed from categories such as risk factors and education level.

The CQM staff shared the latest CDC Morbidity and Mortality Weekly Report on meningococcal disease. According to the preliminary report, twenty-nine meningococcal disease cases were reported nationwide among persons with HIV in 2022. This number is substantially higher compared to previous years and contains a larger number of cases unrelated to an outbreak among MSM. The CDC recommended a two-dose primary series of MenACWY vaccine followed by a booster dose every five (5) years for those living with HIV. Other recommendations to healthcare workers included maintaining high suspicion for meningococcal disease when someone with HIV presents with symptoms and screening patients with meningococcal disease for HIV.

After the discussion, CQM Support Staff announced that Care Resource would present the next case study.
