I. Call to Order

II. Welcome/Introductions

III. Oral Health Presentation by Mark Schweizer, DDS MPH

Dr. Mark Schweizer gave a presentation on "Oral Health and HIV," which he will also share at the Ryan White conference. During this presentation, he discussed barriers to oral health care for patients living with HIV, provided tools that can be utilized to improve patient engagement and retention, and described an educational program to improve student and provider knowledge.

IV. Oral Health Brochure Discussion

A representative from NSU discussed creating an Oral Health brochure for the Ryan White Part A (RWPA) clients. The brochure would be a collaborative approach with all the agencies that provide oral health services under RWPA. This brochure will be distributed to other providers to help educate clients on oral health services and provide positive changes to reduce the stigma around dentistry. Dr. Mark Schweizer shared his oral health brochure from AETC to provide an example to the Network group. He suggested gathering ideas together and volunteered to start working on the format. A representative from AHF stated that an excellent way to identify patients' concerns regarding oral health services is to ask about their previous dentist's experience.

The CQM staff shared the "Broward County Ryan White Part A Program Oral Health Service" document created a few years ago. Since the information is out-of-date, the CQM staff asked every oral health provider to email any updates to the document.
