I. Call to Order

The meeting was called to order at 9:05am.

II. Welcome/Introductions

CQM Support Staff welcomed all attendees, stated the meeting's goal, and made individual introductions.

III. FY 2022-2023 Quality Improvement Project (QIP) Poster Presentation

The CQM Support Staff started the meeting by reviewing the FY2022-2023 calendar for the Quality Network's QIP. The network is in Step 6: Summing it All Up, which is the last step of the QIP process. CQM Support Staff announced that this is the last meeting for this fiscal year.

Each agency presented their final poster presentations of Checkpoint 7 to the Quality Network.

During their presentation, a representative from Nova Southeastern University discussed the quality assurance data issues they are having with Provide Enterprise (PE). They stated that whenever they run reports to assess active Ryan White clients, they see inactive clients within the report, which messes up the validity of their data. The NSU representative stated that they have been working with tech support from PE to resolve this issue.

A representative from Broward House asked if it were possible for agencies to collaborate together for future QIPs in the upcoming fiscal year. They stated that they would be interested in working with another agency to identify gaps related to PE process issues and data entry. CQM Support Staff and Recipient Staff stated that they encourage everyone to work together. CQM Support Staff stated that they will follow up with these agencies within the new fiscal year to discuss possible collaboration ideas in March 2023.

IV. Announcements

CQM Support Staff stated that they will be mailing the Quality Award certificates to all recipients in the last week of February. The providers will get an email notifying them that their packages have been mailed to their respective agencies.
